This MoU is entered on 21<sup>st</sup> December 2021 by and between S.I.W.S. N. R. SWAMY COLLEGE OF COMMERCE & ECONOMICS AND SMT. THIRUMALAI COLLEGE OF SCIENCE, Plot No. 337, Sewri Wadala Estate, Major R. Parmeshwaran Marg, Wadala, Mumbai 400031 (hereinafter called **S.I.W.S. College**), affiliated to The University of Mumbai and Ms. Rashmi Joshi, Environment Consultant 4/B, 141, Yoganand Society, Vazira Naka, Borivali (West), Mumbai - 400 092 for "Composting Project" (hereinafter called **Environment Consultant**)

This document will serve as the operating agreement between **S.I.W.S. College** and **Ms**. **Rashmi Joshi, Environment Consultant** for the purpose of Composting Project and promoting waste management as a part of Green initiative at **S.I.W.S. College**.

WHEREAS, **S.I.W.S. College** desires to initiate composting project as a green initiative and environment friendly measure and **Environment Consultant** is willing to provide the said service.

## I. Objectives :

- a) To initiate a compost Project in S.I.W.S. College
- b) To create awareness on recycling of waste to staff and students as an environment friendly measure
- c) To enable students involvement in green initiatives through environment friendly programs like seminars and workshops.

# II. Roles and Responsibilities of Environment Consultant:

- 1) To conduct seminars and workshops and other activities for students about the use of waste as resource and its relationship with climate change and global warming
- Promote knowledge and provide training to students for segregation of waste at source and composting of biodegradable waste.
- 3) Involve students in the projects and sensitize them on various environment issues.
- 4) Provide training for the housekeeping staff and conduct periodic supervision once in a week in the first month and then once in a fortnight for a period of three months from the initiation of composting project in the college premises.

# III. Roles and Responsibilities of College

- 1. The S.I.W.S. College will make all the arrangements for all the awareness programs.
- 2. Students and staff will actively participate in the recycling of the waste.
- 3. Composting Project will be monitored on a regular basis by students after implementation.
- 4. College will nominate two faculty members as co-ordinators who will submit the activity report every month.

# IV. Terms and Conditions :

- a. Environment Consultant will continue to provide service to S.I.W.S. College
- b. This MoU may be amended, renewed and terminated by mutual written agreement of the parties at any time.
- c. Either party shall have the right to terminate this MoU upon 30 days prior written notice to the other party.
- d. On mutual consent of both the parties, review meetings will be conducted once in three months with co-ordinators, Vice-Principals and Principal.
- e. Environment Consultant shall provide a report to the S.I.W.S.College once in three months about the activities conducted.
- f. The delivery of Environmental services by Environment Consultant should be within the established policies and procedures of S.I.W.S. College and in accordance with their requirements.

# V. Duration of MoU:

This MoU unless extended by mutual written consent of the parties, shall expire in **three years** after the effective date specified in the opening paragraph. However, on review, this MoU shall be extended for another **three years** by mutual consent.

# VI. Space and Utilities:

**S.I.W.S. College** will provide space and utilities to **Environment Consultant** to initiate the waste pit that includes leaf litter, Canteen waste, shovel etc.

**IX. S.I.W.S. College** will intermittently review practices of **Environment Consultant** to monitor outcomes and fulfilment of the compliances.

All activities undertaken through this memorandum are for the purpose of maintaining green initiatives and environment friendly campus supporting **S.I.W.S. College's** educational mission. **Environment Consultant** will work collaboratively to meet goals, objectives and requirements of **S.I.W.S. College**.
