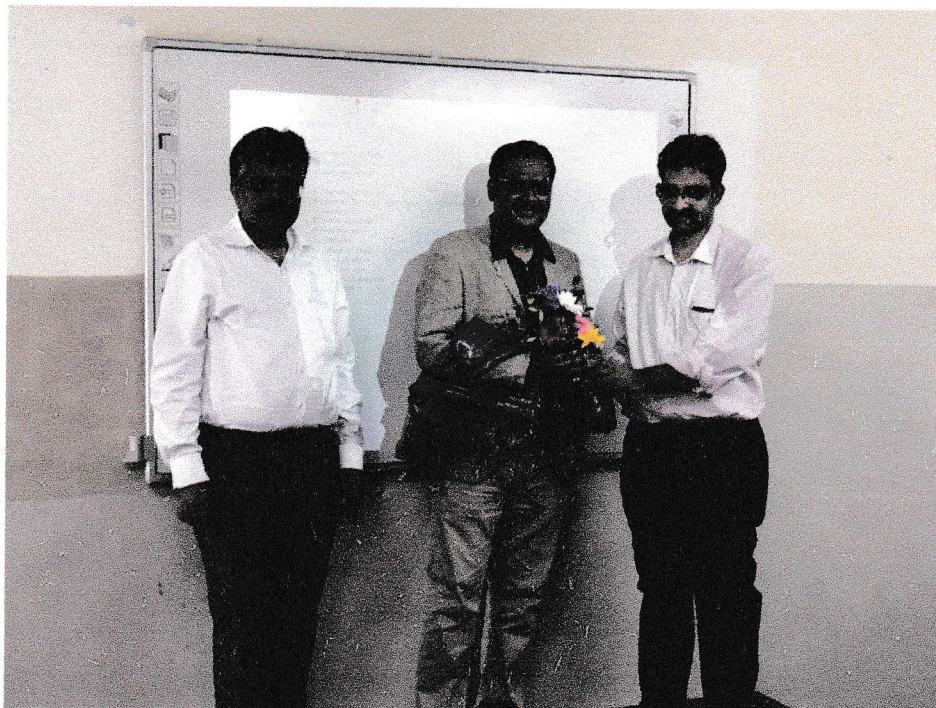
Annual Report: 2018-2019

shopping and consumer disputes redressal. She also presented nuance of basic rights of consumer with regards to advertising claims and how to protect the best interest of the consumers.

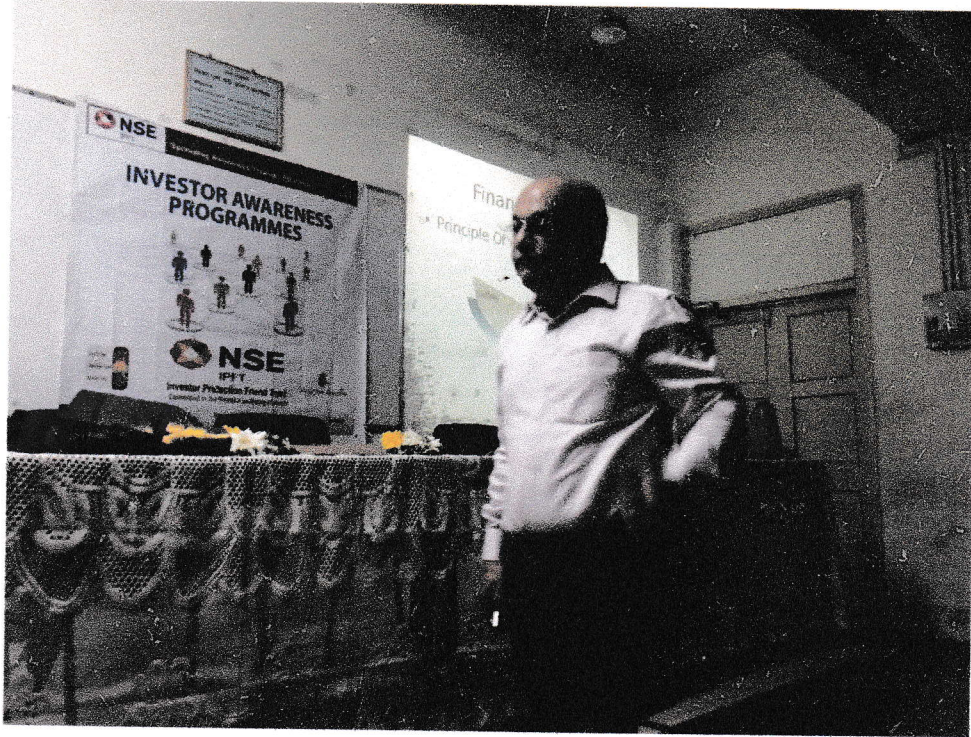

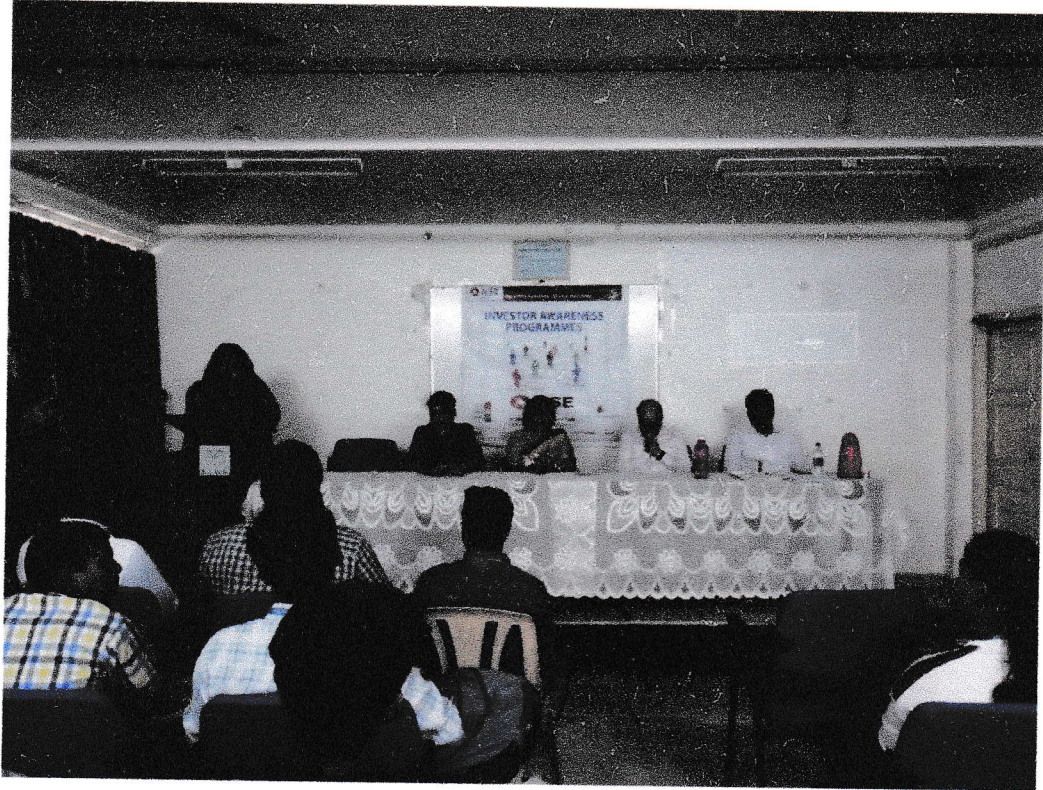


