3. Total of 63 students enrolled for the course.

Students will get a holistic view of the legal provisions of the Companies Act, 2003 and Limited Liability Partnership Act, 2008 along with its practical applications. Students will have a practical overview of filing of financial statements and other related forms on the MCA portal. This course will enable students to develop skill sets with respect to Accounting & Company Law which will be useful for employment and professional courses.







4. I.Q.A.C., Department of Accountancy and B.Com (Accountancy & Finance) jointly organized an Online Certificate Course in 'BASICS OF E-FILING UNDER INCOME TAX LAW' between 16th to 30th October, 2021. Total of 35 students enrolled for the course. Every assessee having a taxable income is required to file an Income Tax Return. The Government of India introduced a new Income Tax E-filing portal this year. This portal has been designed to make income tax compliances less tedious and less complicated. The huge number of assessees

coupled with use of technology to file income tax returns has created a range of opportunities for tax professionals. It is imperative that the theoretical knowledge of the Income Tax Act, 1961 is complemented by the knowledge of procedures and compliances that need to be carried out. In this age of electronic filing and compliance, it is also imperative for students to understand the operation of the new Income Tax E-filing portal.

The course intends to provide theoretical and practical knowledge of the provisions of the Income Tax Act, 1961 and the filing of the income tax returns for different types of assesses. The course faculty



comprises of academicians and professionals practicing in IncomeTax.

Students will get a holistic view of the legal provisions of the Income Tax Act,1961 and the amendments there of. Students will have a practical overview of filing of various return of income under Income Tax Act. This course will enable students to develop skill sets with respect to Income Tax filings which will be useful for employment and pursuing professional courses.

5. I.Q.A.C., and Department of Accountancy, MCOM, BMS, BBI & BAF jointly organised an Online

Certificate Course on "MUTUAL FUND DISTRIBUTORS CERTIFICATION EXAMINATION" for all Commerce students between 6–18 December, 2021. Total of 90 participants enrolled for the course.

To have a knowledge workforce in the industry National Institute of Securities Markets (NISM) has introduced certificate course. S.I.W.S college has introduced the certification course in order to announce the employability skills in Mutual Fund (MF) industries.





The Main Objective of the course was to enable the students to have knowledge of Mutual Fund, to enable the students to appear for NISMVA Certificate Exam.
